Rank: Assistant/Associate Professor (Tenure-Track)

Qualifications: *Required:* Doctorate in Education or related discipline with expertise in multicultural education by time of appointment. Demonstrated potential for scholarly activity in the area of multicultural education, teacher education, and/or teacher professional development. Knowledge of public schools, instructional strategies, and assessment models with particular expertise in how they shape the learning experiences of multicultural populations. Teaching experience in one or more educational settings. Demonstrated awareness of and sensitivity to the educational goals of a multicultural population evidenced by cross-cultural study, training, teaching, and other comparable experience. Ability to work well in collaborative settings. For appointment at advanced rank: a record of publications and/or grants and substantial teaching experience.

Preferred: Preference will be given to candidates who possess one or more of the following: (1) research expertise and experience in multicultural education, including an intersectional approach to issues of sexism, gender, and sexuality; (2) experience teaching/working in Grades 6-12 in schools characterized by cultural and linguistic diversity; (3) proficiency in one or more languages other than English represented in our service area (e.g., Spanish, Mandarin, or Vietnamese); (4) evidence of working for social justice, educational equity, and multilingualism, specifically in Grade 6-12 school communities; (5) expertise in using technology to enhance teaching and learning; (6) expertise in second language acquisition and meeting the needs of second language learners; (7) experience with differentiation and using a range of pedagogical strategies to support culturally, academically, and linguistically diverse student populations; (8) expertise and/or experience in providing services to students with special learning needs (e.g., Special Education credential, MTSS, etc.) and/or (8) expertise with action research or other qualitative methods. The Department of Teacher Education is especially interested in candidates who are knowledgeable of California public schools and experienced in building networks, partnerships, or collaborations with schools in culturally diverse communities.

Responsibilities: Teach courses in teacher education, particularly coursework related to foundational theory and research in multicultural education and its application to teaching. Supervise student teachers and participate in student advisement. Participate in developing school/university partnerships. Participate and/or take a leadership role in Department/College/University committee work and in curriculum/program support and development. Maintain an active and productive research program and participate in scholarly associations at the regional, state, and national levels. Candidates must address the needs of a student population of great diversity – in age, cultural background, ethnicity, primary language, and academic preparation – through course materials, teaching strategies, and advisement.

Salary Range: Commensurate with qualifications and experience.
