THE UNIVERSITY: The University of La Verne, located in La Verne, California is a 124 year old, independent, comprehensive, doctoral granting institution in Southern California with a strong emphasis on teaching excellence, community engagement, and an increasing commitment to research and publication. The University is composed of the College of Arts & Sciences, College of Business & Public Management, College of Education and Organizational Leadership, College of Law, and a Regional Campus Administration.

THE COLLEGE: The College of Education and Organizational Leadership (CEOL) is recognized as providing premier programs of higher learning engaged in the training of leaders and professional educators throughout California. The College encompasses two of the University's strongest and most recognized departments: Advanced Studies in Education and Human Development, and Education and Teacher Development. It is renowned for the excellence of the elementary and secondary teachers who complete its Teacher Education program and has maintained this regional reputation for over half a century.

THE DEAN: The Dean of the College of Education and Organizational Leadership is the chief academic, administrative, and financial officer of the College and reports to the Provost. The Dean assumes responsibility for College accreditation and implements outcomes assessment for all academic programs; insures academic quality; oversees recruitment, evaluation, promotion and tenure of 69 faculty; supports faculty enrichment and development in teaching, scholarship, and solicitation of grants; oversees the planning and execution of the budget, and actively participates in fundraising.

REQUIRED QUALIFICATIONS – The successful candidate will have the following qualifications:

- A Ph.D. or terminal degree from a regionally accredited institution (or the equivalent) in a discipline within a College or a related field;
- Record of successful teaching and service in higher education;
- A distinguished record of scholarship and publication;
- At least 5 years' experience in academic leadership in higher education;
- Demonstrated commitment to diversity and inclusivity in building a multicultural teaching and learning community;
- Track record of fund raising and grant writing; and
- Experience with state and national accreditation procedures in higher education.
