“Artful Teaching in Testy Times” Is Theme for Spring 2005 CCTE Conference

The Spring 2005 Conference of the California Council on Teacher Education will be held March 31 to April 2 at the Hyatt Sainte Claire Hotel in San Jose. The theme for the Conference is “Artful Teaching in Testy Times.”

The Spring Conference committee, co-chaired by Paul Ammon and Della Peretti of the University of California, Berkeley, offers the following description and invitation: “At a time when life in schools is being heavily impacted by high-stakes testing and test-driven curricula, it is vital that educators strive to incorporate the arts into their work with students. The arts can enhance the quality of life and learning for all students, and can provide access to a good education for many who are not otherwise engaged.”

Amalia Mesa-Banes of California State University, Monterey Bay, will deliver a keynote address on Thursday afternoon of the Conference, stressing why it is important to integrate arts into teacher education and to prepare teachers to do the same in their own teaching.

On Friday there will be a morning-long research and practice session devoted to drop-by posters/exhibits/workshops that will provide various examples of what integration of the arts looks like in actual teacher education programs and K-12 classrooms.

At the Friday luncheon Maxine Greene of Teachers College, Columbia University, will be the guest of CCTE via a live media hook-up from New York City. She will receive an award for her life-time contributions regarding the arts in education and will speak to the Conference about that interconnection.

Friday afternoon will feature a panel presentation on how teacher education programs can go about integrating the arts as well as a set of concurrent research and practice sessions. The Conference will also include meetings of the CCTE Special Interest Groups, policy sessions, and a banquet on Thursday evening.

The Spring Conference Committee stresses that it plans to offer opportunities for those attending the Conference to experience the arts, both within the Conference itself and in the surrounding San Jose area, throughout the days and evenings of the Conference.

The Spring Conference is again being co-sponsored by the Independent California Colleges and Universities Council on Education of Teachers (ICCUCET) and the California Association of Professors of Special Education (CAPSE). Both of those organizations will hold meetings on the morning of Thursday, March 31.

The tentative Spring Conference program appears on Page 2 of this issue of *CCNews*, and the conference registration form is on Page 3. The pre-registration deadline is March 11, so you are encouraged to register as soon as possible; on-site registration will also be available at the Conference. My President’s message for this edition of *CCNews* has a rather unusual style (letter format) and intent, at least with regard to this organization in the twenty plus years of my involvement. CAPSE To Consider Implications of IDEA 04

The next meeting of CAPSE, the California Association of Professors of Special Education, will be held on Thursday, March 31, at 9:00 a.m., during the Spring CCTE Conference in San Jose. Immediately following will be a meeting of the Special Education Special Interest Group of CCTE. All who are interested in the preparation of special education teachers and related professionals are urged to attend.

An important issue on the table will be the implications of the recently passed IDEA 2004, which re-authorizes IDEA, the main federal legislation for special education, while making some significant changes from previous iterations of this bill. The CAPSE membership will need to deliberate on the role and responsibility of teacher educators in the implementation of this new law in California. Specific items will include:

- ◆ The definition of a “highly qualified” special education teacher, and how it aligns with credentialing requirements in California.
- ◆ The role of the special education teacher in a time of major changes in service delivery.
- ◆ The implications of these two issues for the content and field experiences in our teacher preparation programs. For example, how do we effectively and efficiently prepare teachers in both subject matter knowledge and specialized methodologies for students with disabilities? What combination of general education and special education field experiences is best?

CAPSE members are also involved in initiatives concerning many other vital issues, including recruitment and retention strategies to address the long-standing need for more special education teachers, the preparation of teachers to work with students in low-incidence disability areas, and the shortage in the special education professoriate.

Dialogue with our liaisons at the California Commission on Teacher Credentialing and the California Department of Education will be an essential aspect of the meeting. We look forward to lots of networking and sharing of information, as always! For further information, please contact me.

John Sikula To Speak at PDK Event in San Ramon

The Hayward and Diablo Chapters of Phi Delta Kappa (PDK), an international educators group, have invited John Sikula, a nationally known educator with past ties to California and CCTE, to address their joint meeting in March. The dinner meeting will take place on Monday, March 7, 2005, from 6 p.m. to 9 p.m., at Bighorn Grill in San Ramon.

Sikula will speak from a national perspective on “Good News About American Education Today.” He will present what works in establishing effective schools, based on his experience and the educational literature. His points will cover all levels of education and are designed to encourage educators who seek to provide the best schooling for our nation's children.

Following Sikula's presentation, there will be time for table discussions. Discussions will address three questions: (1) What place should the federal government have in determining what improvements should be made in the public schools? (2) Will No Child Left Behind (NCLB) succeed in identifying our failing schools and in providing the appropriate steps for solving the problems of failing schools? (3) Should schools emphasize teaching basic skills?

The presentation and table discussions will be followed by a panel that will respond to questions and issues raised. The panel will include: Sikula, the Associate Provost and Dean of the Graduate School at Ashland University in Ohio; David Stronck, Professor of Education at California State University, Hayward; Garo Mirigian, Principal at Centerville Middle School in Fremont; Patsy Lockhart, Core Language Arts Teacher at Barnard-White Middle School in Union City; Helen Vayntrub, a math intern teacher at Ygnacio Valley High School in Concord and a candidate for a teaching credential at CSU Hayward; and Juanita Haugen, a 25-year member of the Pleasanton School Board. The six of them will provide a broad array of perspectives and will be an excellent resource for responding to questions arising from the table discussions.

The cost for this meeting is \$32 per person. The first 20 current CSU Hayward students (undergraduate or graduate) to submit their meeting registration form and check will receive a \$10 reimbursement. CCTE Policy Framework

The California Council on Teacher Education (CCTE) supports and encourages approaches to the preparation and continuing development of teachers which:

- ◆ Work toward the integration of the professional preparation of educators into career-long professional development involving sound theory and effective practices at all stages.
- ◆ Establish and foster strong support programs for teachers at all stages of their careers, particularly at the beginning stage, to help attract and retain high-quality teachers; such programs should include a role for university-based personnel as well as practitioners from the schools.
- ◆ Recognize and support university and school personnel who work in partnerships to improve preservice preparation, induction, and professional development of educators.
- ◆ Assure that professional programs include both scholarly study and school-based practice involving collaborative exchanges and cooperation between university and school personnel.
- ◆ Foster the strong and balanced preparation of teachers in subject matter content, foundational studies, multicultural and multilingual education, and sound pedagogical practice at all levels of the professional development continuum.
- ◆ Assure that the guidelines, regulations, and laws governing the preparation of teachers and other educational personnel in California are based on, and are continually informed by, research and best practice; and that these guidelines, regulations, and laws reflect the considered opinions and voices of experts in the field.
- ◆ Include multiple and alternative approaches to the admission, retention, and credential recommendations for prospective teachers; and assure that all measures used to assess candidates at any point in their preparation are valid, unbiased, and relevant to teaching and learning practice.
- ◆ Support accreditation and evaluation processes which improve professional practice and which are conducted in an unbiased, collegial atmosphere by university and school professionals.
- ◆ Seek and ensure the active participation of the teacher education community in policy discussions and decisions regarding preservice education and the professional development of educators.
- ◆ Foster public and political support for education at all levels, pre-K to university.
- ◆ Recognize that quality teacher education is an intensely interactive and highly individualized activity requiring stable and adequate financial and personnel resources for ongoing development of effective teacher preparation programs.

Awards committee Chair John Sikula—who established the unit awards program 17 years ago when he was the ATE President—has personally financed it ever since. John telephoned at the beginning of January to let me know that CCTE was selected to receive the award, and he told me that the committee was very impressed with our application and materials, which we had submitted in a portfolio binder. At the Awards Ceremony John publicly praised CCTE's accomplishments in 2004, asked me to hold up the portfolio binder, and suggested that other states view it as an example of what a successful entry for the unit award looks like.

Many of us know that John, who is now Associate Provost at Ashland University in Ohio, was at one time an active member of the California teacher education community and that he began the state of California's first ATE unit—known over several years as SCATE until it was merged as part of CCTE a few years ago. My sincerest thanks to John and his committee for their work in reviewing all the applications and for his generous support of the awards program.

As the Outstanding ATE Unit for 2004, CCTE received a beautiful plaque and a check for \$500. The plaque and portfolio will be available for everyone to see at the CCTE spring 2005 conference in San Jose.

When I mailed the portfolio binder to John's committee in December, I thought that whether we won an award or not, certainly CCTE *is* an outstanding organization. We have many, many dedicated leaders, editors, and members who routinely contribute generously to Cal Council. Personally, I also think that Alan Jones's work as our Executive Secretary and publisher has a lot to do with our overall success as an outstanding state unit.

Finally, I've never been all that interested in external

prizes, which sometimes take away from the sense of intrinsic value for activities and projects that individuals or groups choose to emphasize. Nonetheless, as an organization, we might use our ATE award application as a tool for assessing areas that could be strengthened—not in order to be more competitive with other units in the future, but rather to be more open to possible areas for growth. Just a thought.

Fundamentally, CCTE's clear focus is on children. We are dedicated to improving teacher education in order to strengthen pre-K-14 education. We want *all* of the children of California to have equitable opportunities for high quality schooling experiences.

Many thanks to each and every one of you for everything you did during 2004 to help make CCTE the outstanding organization it is recognized to be by ATE. On behalf of the children!

Call for Proposals for Research and Practice Sessions at the Fall 2005 CCTE Conference

The California Council on Teacher Education (CCTE) invites submission of research and practice proposals for the Fall 2005 Conference to be held October 20-22 at the Shelter Pointe Hotel and Marina in San Diego. The theme of the Fall 2005 Conference is alliance building in teacher education. Proposals are encouraged on that theme, but not limited to it. Proposals are sought for several types of sessions: poster sessions, interactive sessions, demonstrations, workshops, and formal presentations, both individual and groups.

General Procedures: CCTE is interested in receiving proposals from faculty directly involved in teacher education programs, county and school district personnel engaged in BTSA and other teacher induction and professional development efforts, and graduate students conducting research related to teacher education. Presenters will be selected from each of these categories to assure balance in the Fall Conference program.

How To Submit Proposals: Proposals must be submitted electronically. Submit (a) an email file cover sheet listing the names, affiliations, addresses, work and home telephone numbers, and email addresses, along with requested audiovisual equipment; and (b) an email file attachment (preferably in Microsoft Word or Microsoft Office) of a maximum 3-page, single-spaced proposal without names of the presenters. Content of the Proposal: Include the following: A brief overview of the study/project/program session including purpose/objectives, theoretical framework, methods, data source, results/conclusions/points of view, significance to the field of teacher education, and proposed style of presentation.

Deadline: Proposals for the Fall 2005 Conference must be received by September 1, 2005.

Criteria for Selection: The selection criteria are: the proposal contributes to the knowledge base of preservice and inservice teacher education; the proposal is methodologically or theoretically sound; and the proposal clearly states its significance for teacher educators.

Scheduling: The concurrent research and practice sessions will be scheduled on Thursday and/or Friday, October 20 and 21, at times to be determined. Persons submitting proposals must be planning to register for and attend the Conference in order to be available once proposals are accepted and sessions are scheduled.

Miscellaneous: All presentations at CCTE Conferences are eligible for inclusion on the CCTE website following the Conference, and for submission to the ERIC Clearinghouse on Teacher Education. Papers resulting from accepted proposals will also be considered for publication in *Teacher Education Quarterly* or *Issues in Teacher Education*, the two CCTE journals.

CCTE Calls for Nominations for

“Quality Education Partnership Award for Distinguished Service to Children and the Preparation of Teachers”

At each Spring and Fall Semi-Annual Conference, CCTE honors a teacher education program which exemplifies collaborative efforts between a college/university and a K-12 school/district. The CCTE Awards Committee now invites nominations (and self-nominations) from programs in Southern California for the “Quality Education Partnership Award for Distinguished Service to Children and the Preparation of Teachers” that will be presented at the Fall 2005 Conference in San Diego. Next winter the Awards Committee will seek nominations of programs in Northern California for the award to be presented at the Spring 2006 Conference in San Jose.

Nominations must be submitted via e-mail.

Nominees for this semi-annual CCTE award must reflect collaboration between college/university administration and faculty and K-12 school administration and faculty (individual schools, school districts, or county offices of education) in the planning as well as the implementation of the program to be honored. Eligible programs must have been in place for a minimum of three academic years. Such programs may involve public or private/independent colleges/universities and public or private K-12 schools. Nominations must show clear evidence that as a result of the program, all partners have benefitted — e.g., children, student teachers, beginning teachers, cooperating teachers, other teachers and/or administrators in the school or district, and college/university faculty.

Nominations must include the following information: The names of the leading participants in the collaborative effort; a description of the school/district/county office and its population; a history of the program, including original goals and/or research questions being addressed; a description of the perceived successes of the effort, including any synopses of evaluative data collected; and future plans for the project.

Nominations must be submitted jointly by the K-12 school/district/county office and the institution of higher education with a statement of verification by the appropriate college/university and school/district officials. Each official named in the document should send a separate e-mail verification statement.

The total nomination document should not exceed five pages.

Call for CCTE Individual Awards Nominations

Robert R. Roth Distinguished Teacher/Administrator New to the Profession: This award is intended for a teacher or administrator who has worked six years or less at a K-Adult school site, district office, or county office of education. The awardee must exemplify excellence in their primary assignment and in their work to improve the preparation, induction, and professional development of educators.

Distinguished Teacher/Administrator: This award recognizes and honors an outstanding teacher and/or outstanding administrator who has worked more than six years at a K-Adult school site, district office, or county office of education. The awardees must exemplify excellence in primary assignment and in work to improve the preparation, induction, and professional development of educators.

Distinguished Teacher Educator: This award recognizes and honors an outstanding teacher educator who is located at a university/college, community college, or educational agency other than K-12 districts or county offices. The awardee must exemplify excellence in work to improve the preparation, induction, and professional development of educators.

Nomination Procedure: Via e-mail (1) Submit an essay describing the work of your nominee with particular attention to evidence of excellence in primary professional assignment; history and evidence of commitment to and success in teacher preparation; and ways in which the nominee’s work reflects the goals of CCTE; (2) Include with your essay documentation/evidence (including nominee’s CV) to support your claims; (3) Cover page to include: Name of Award; Name of Nominee; Nominee’s Address, Phone, e-mail; Name of Nominator; Nominator’s Address, Phone, e-mail; (4) Send nomination information via e-mail by September 1, 2005, to: arlinda.eaton@csun.edu

Case Methods in Teacher Education: This group examines the use of case methods in the preparation of teachers, including the identification and sharing of case studies and case methods, and the refinement of materials available in this field. SIG coordinator: Michael Fanning, St. Mary's College of California.

Coalition for Educational Renewal: The California Coalition for Educational Renewal is the state arm of the national network inspired by the work of John I. Goodlad. Coalition meetings focus on activities at California campuses which operate as part of the national network. SIG coordinator: Sally Botzler, Humboldt State University.

Credential Program Coordinators: This SIG offers an opportunity for coordinators of credential programs at colleges and universities across California to exchange information, discuss issues, and develop coordinated plans. SIG coordinator: Jose Lalas, University of Redlands.

Deans and Directors of Teacher Education: This new SIG seeks to offer deans, directors, and chairs of schools, colleges, and departments of teacher education an opportunity to exchange information and perspectives on administrative, fiscal, and policy issues. Educational Foundations: What do we mean when we say that we teach Educational Foundations? What are our purposes? How do we teach it? Equity and Social Justice: This SIG, which met for the first time at the Fall 2000 Conference, is closely aligned with the mission of CCTE in general, and seeks to offer augmented support for a democratic vision in the field of teacher education. Lives of Teachers: This SIG is intended for educators interested in conducting research, doing writing, or just discussing topics related to: (1) the evolution of teachers' careers, including the stages or "passages" that mark various phases of this evolution; (2) teacher biography and autobiography, with special emphasis on the stories that teachers tell about their professional lives; and (3) teacher professionalism, i.e., those features that distinguish teaching from other professions. National Board Certification: This SIG considers issues in California related to National Board Certification of teachers. SIG coordinator: Judith Shulman, WestEd.

CCTE Annual Election for 2005 Underway

The 2005 CCTE annual election involves election of three members of the Board of Directors, each of whom will serve three-year terms running from the Spring 2005 Conference through the Spring 2008 Conference. Other CCTE officers are elected in even numbered years, so those positions are not up for election this spring.

The current CCTE officers and the membership of the Board of Directors appears on the next page of this issue of *CCNews*, with the years following each name indicating the term of office. The three members of the Board of Directors whose terms expire this spring, and who will therefore be replaced through this year's election, are James Cantor, Marilyn Draheim, and Magaly Lavadenz.

The Nominations and Elections Committee, chaired by CCTE Past President Andrea Maxie, has, as required by the CCTE by-laws, offered a slate of nominees for the offices to be elected, with twice as many nominees as there are positions to be filled. The persons nominated by the committee for positions on the Board of Directors are:

These six nominations were announced to the CCTE membership in a mailing in January of this year, and additional nominations were invited by petition from the membership. No additional nominations were received by the February 10, 2005, deadline.

A final election mailing containing the final list of nominees, statements of candidacy for each nominee, and a ballot and return envelope was sent out in mid-February. Each delegate and member may vote for up to three candidates for the Board of Directors. Delegates and members may submit ballots by mail or may wait to turn in ballots at the Spring Conference in San Jose. Either way, ballots are to be returned in the small return envelope provided, which bears the name of the voter as a return address. Envelopes returned by mail will be held unopened by the Executive Secretary and turned over to the Nominations and Elections Committee at the Spring Conference. Ballots being mailed in must arrive to the Executive Secretary by March 28. Envelopes containing ballots may also be turned in to the Executive Secretary at the registration desk at the Spring Conference until noon on Friday, April 1, and those envelopes will also then be turned over to the Nominations and Elections Committee. When the Committee opens the envelopes, the ballot and envelopes will be immediately separated to protect the privacy of votes by each delegate and member.

The deadline for receiving ballots at the Spring Conference is noon on Friday, April 1, at which time the Nominations and Elections Committee will tally the ballots. Delegates and members who have not mailed or turned in their ballots as of 11:45 a.m. that morning may vote in person at the Conference registration desk until noon that day; to vote in person members and delegates must bring their ballot and envelope with them.

The Nominations and Elections Committee will then complete the tally of the ballots at noon on Friday, April 1, and the three candidates receiving the most votes for the Board of Directors will be declared elected and will take office immediately upon announcement of the election results that afternoon at the Spring Conference.

The offices of President Elect, Vice President for AACTE, and Vice President for ATE will be elected that year for two-year terms running until 2008.
