<u>Theme for the CCTE Fall 2006 Conference:</u> "Educating All Students for the Future: Strengthening the Special Education/ General Education Partnership"

The Fall 2006 Conference of the California Council on Teacher Education, with theme "Educating All Students for the Future: Strengthening the Special Education/General Education Partnership," will be held October 19-21 at the Kona Kai Resort in San Diego (formerly the Shelter Pointe Hotel and Marina). This Fall the Conference is jointly cosponsored by the California Association of Professors of Educational Administration (CAPEA), the California Association of Professors of Special Education, Teacher Education Division (CAPSE/TED), and the Independent California Colleges and Universities Council on the Education of Teachers (ICCUCET).

Building upon CCTE's commitment to social justice and the importance of creating alliances for teacher education, the Fall 2006 Conference will explore the theme of including and educating all students. Teacher educators and other interested professionals will come together to consider the empirical, political, and practical ramifications of partnerships that prepare all teachers to educate students with disabilities. Inclusion, collaboration, co-teaching—how do we empower our current and future teachers to embrace these research-based practices? Accommodations and modifications in assessment and instruction—what works? Model programs, teacher preparation curricular materials, promising directions in credential design—gather new ideas!

Teacher educators in special education and general education are looking forward to forging new alliances that will strengthen our preservice, induction, and inservice efforts on behalf of California's students who have disabilities. The Fall Conference will seek to provide an open and proactive exploration of teacher education's role our values, beliefs, and actions—as we prepare California's teachers to educate all children.

Program Highlights

The keynote speaker on Thursday afternoon, October 19, will be **Stuart Schwartz** of National University and the keynote speaker on Friday morning, October 20, will be **Deborah Smith** of Claremont Graduate University. The three-day program will feature panel presentations, policy sessions, special interest groups, research sessions, miniworkshops, a reception and banquet on Thursday, an awards luncheon on Friday, a silent auction, and ample opportunities for networking and meeting new teacher education colleagues from across the state. The Saturday morning program will feature several practice-oriented models that can be put to immediate use in teacher education programs to address the special education/general education interface.

The tentative program for the Fall Conference appears on the next page of this newsletter, and other information about the Conference is also included—look for details about the Special Interest Groups that will meet, the silent auction, the sing-a-long following the banquet, and many other Conference activities.

Who Should Attend?

Teacher educators, including subject matter faculty, at colleges and universities (two-year, four-year, and graduate), BTSA directors and staff and other K-12-based teacher educators, supervisors of student teachers, classroom teachers, school district and county office staff development personnel, students in credential programs, state education leaders, members of professional associations, staff at research centers—everyone interested in and involved in teacher education, induction, and professional development across California should attend the Fall 2006 Conference. There is a special registration rates for first-time attendees. It is not necessary for one to be a CCTE delegate or member to attend the Conference, although membership is encouraged.

CCTE Special Interest Groups (SIGs) Which Will Meet at the Fall 2006 Conference

Two new CCTE Special Interest Groups will meet for the first time at the Fall 2006 Conference. The new SIGs are *BTSA and Induction* and *International/Global Teacher Education*. Spectific information on each SIG follows:

Arts in Education: This SIG explores issues and developments related to the integration of the arts into teacher education and K-12 education. SIG coordinator: Della Peretti, University of California, Berkeley. Meeting time at Fall Conference: Thursday at 12:15 p.m.

BTSA and Induction: This new SIG will provide an avenue for continuing exploration of the work of BTSA programs and the role of induction in the California teacher education continuum and the relationship and integration of those efforts with preservice teacher education. SIG coordinator: LaRie Colosimo, Claremont Unified School District. Meeting time at Fall Conference: Friday at 3 p.m.

Case Methods in Teacher Education: This group examines the use of case methods in the preparation of teachers, including the identification and sharing of case studies and case methods, and the refinement of materials available in this field. SIG coordinator: Keith Walters, Biola University. Meeting time at Fall Conference: Thursday at 12:15 p.m.

Coalition for Educational Renewal: This SIG explores issues related to implementation of the ideas of the national educational renewal movement in California. SIG coordinator: William Rich, California State University, Chico. Meeting time at Fall Conference: Friday at 3 p.m.

Coordinators of Credential Programs: This SIG offers an opportunity for coordinators of credential programs to exchange information, discuss issues, and develop coordinated plans. SIG coordinator: Jose Lalas, University of Redlands. Meeting time at Fall Conference: Friday at 3 p.m.

Deans and Directors of Teacher Education: This SIG seeks to offer deans, directors, and chairs of schools, colleges, and departments of teacher education an opportunity to exchange information and perspectives on administrative, fiscal, and policy issues. SIG coordinator: New coordinator to be selected. Meeting time at Fall Conference: Friday at 3 p.m.

Educational Foundations: What do we mean when we say that we teach Educational Foundations? What are our purposes? How do we teach it? The range of interpretations, purposes, and approaches varies from instructor to instructor

and by institution. Given this milieu, we come together at CCTE to share with and learn from each other. SIG coordinator: Karen D. Benson, California State University, Sacramento. Meeting time at Fall Conference: Thursday at 12:15 p.m.

Equity and Social Justice: This SIG is closely aligned with the mission of CCTE in general, and seeks to offer augmented support for a democratic vision in the field of teacher education. SIG co-coordinators: Anaida Colon-Muniz, Chapman University, and Tim Mahoney, California State University, Stanislaus. Meeting time at Fall Conference: Friday at 3 p.m.

International/Global Teacher Education: This new SIG will explore issues and practices related to teacher education in the international/global context. SIG coordinator: Reyes Quezada, University of San Diego. Meeting time at Fall Conference: Thursday at 12:15 p.m.

Lives of Teachers: This SIG is intended for educators interested in conducting research, doing writing, or just discussing topics related to: (1) the evolution of teachers' careers, including the stages or "passages" that mark various phases of this evolution; (2) teacher biography and autobiography, with special emphasis on the stories that teachers tell about their professional lives; and (3) teacher professionalism, i.e., those features that distinguish teaching from other professions. SIG coordinator: Jerry Brunetti, St. Mary's College. Meeting time at Fall Conference: Thursday at 12:15 p.m.

Special Education: This SIG offers an opportunity for discussion and exchange between teacher educators interested in and involved in the field of special education. SIG coordinators: Michele Cepello, California State University, Chico, and Lou Larwood, San Jose State University. Meeting time at Fall Conference: Thursday at 12:15 p.m.

Technology and Teacher Education: This SIG explores issues and innovations in technology that impact and offer promise to the field of teacher education. SIG coordinator: Heidi Stevenson, University of the Pacific. Meeting time at Fall Conference: Friday at 3 p.m.

The SIGs will meet concurrently, at two different times, during the Fall Conference. All CCTE SIGs are open to any interested persons. Each person attending the Fall Conference is encouraged to attend SIGs of his or her choice.

We are extremely proud to be able to sit at the same table with such colleagues.

At the national level, we are delighted with the leadership role our Vice Presidents for AACTE and ATE, Joel Colbert and Ann Wood, play in placing CCTE at the forefront of AACTE and ATE activities. We especiallylook forward to assisting ATE when the national organization meets in San Diego this coming February. I congratulate Ann for being elected to the ATE Board. As a way to further expand CCTE's national and international involvement, we will advertise a call for proposals for our future conferences in the *Chronicle of Higher Education* and the *International Council for Educating Teachers (ICET) Newsletter*.

Also at the international level, we congratulate Tom Nelson, editor of *Teacher Education Quarterly*, on the appointment of the outstanding new international advisory board for the journal. The Fall 2007 CCET Conference will focus on internationalizing schools and colleges of education, and I will be seeking conference committee volunteers. Anyone interested in being in the committee is asked to contact me.

Report from the CCTE Legislative and Educational Policy Analyst

End of 2005-2006 Legislative Session Draws Near

(this report as of August 21, 2006)

Lawmakers returned to the Capitol on August 7, 2006, after a one-month summer recess. Approximately 1,5000 bills remained for debate and action by the legislators. The majority of the bills were in the fiscal committees of each house. The legislature has approximately a week and a half to conclude its business. It is scheduled to adjourn for the year on August 31, 2006.

The Governor has made several issues his priority upon the return of the Legislature. Prison overcrowding is one for which the Governor is calling for a special legislative session to consider a \$6 billion dollar plan—to be funded by bonds to build two new prisons, improve transitional facilities, and expand treatment programs. Another legislative priority is the negotiating of a green-house bill to gradually lower levels of smog-causing pollutants "without hurting the economy." Additionally, according to the Governor's office, the Governor wants to restore two items cut from the state budget before he signed the budget bill: \$1.6 million to operate the State Board of Education and up to \$23 million to increase the number of low-income children covered by health insurance.

The fiscal committees of each house met these past two weeks to determine the fate of many bills that remained in their committees because the bills required appropriations or due to general fund pressures contained in the bills. Education bills that were voted upon favorably by members of the fiscal committees and are continuing through the legislative process include, but are not limited to, the following bills.

AB 1381 (Nunez) Gives Los Angeles Mayor Villaraigosa, and future Los Angeles Mayors, the power to ratify the hiring and firing of the Los Angeles Unified School District Superintendent; one among many major provisions.

AB 2248 (Coto) Among other provisions, authorizes up to three additional years of funding for the Reading First Program, pursuant to the availability of federal funds, to local educational agencies that demonstrate "significant progress" as defined in the bill.

SB 472 (Alquist) Reauthorizes the professional development provisions for reading and mathematics established pursuant to AB 466 of 2002. New provisions in the bill include an English language learner component.

SB 1290 (Scott) Among other provisions, streamlines teacher credentialing for out-of-state teachers.

subjects credential or a special subjects teaching credential, or teachers with a special class authorization to receive a certificate of completion to provide specially designed academic instruction (SDAIE) delivered in English to pupils who are English language learners, if the teacher completes or is enrolled in, a staff development course in SDAIE.

SB 1580 (Ducheny) Conforms California's testing policy of English language learners to the testing provisions of the NCLB specific to English language learners. Additionally, requires the scores of the standards aligned primary language assessments to be include in California's AYP and the API.

SB 1769 (Escutia) Requires the State Board of Education to allow publishers to submit for approval, textbooks that are aligned to both English Language Arts and the English language Development standards for the purpose of providing an accelerated English program for English Language Learners. The bill also restores funding to the State Board of Education.

Bills that failed to "pass out" of the fiscal committees include, but are not limited to:

SB 1824 (Migden) Proposed to reestablish the California Preliminary Credential Program (CAP) authorizing local school boards to recommend to CTC for credentialing purposes, individuals with expertise in math or science, for a single subject credential. This bill was opposed by CCTE.

SB 1073 (Simitian) Establishes California Subject Matter projects in art, physical education, and foreign language. It proposes to extend the sunset date for all of the California Subject Matter projects from June 30, 2007 to June 30, 2014.

SB 1124 (Torlakson) Authorizes several initiatives to improve the recruitment, training and retention of teachers. Provisions include providing funding for the purpose of paying fees for teachers who seek certification from the National Board for Professional Teaching Standards.

SB 1433 (Torlakson) Establishes the California Teacher Leadership Pilot program until January 1, 2009 to provide funding to local education agencies ranked in deciles one through three of the API to train experienced teachers to become instructional coaches in an effort to support local statewide improvement programs by building capacity for professional development.

SB 1292 (Scott) Authorizes a teacher with designated

AB 172 (Chan) Requires the State Superintendent of Public Instruction to convene a committee for the purpose of developing a plan to coordinate the capacity and efficiency of state postsecondary education institutions to train staff for preschool programs.

AB 1246 (Wolk) Requires the State Superintendent of Public Instruction to develop and adopt preschool learning standards and to develop school curriculum guides in four specified areas.

Last but not least, a bill will be amended in order to

implement the \$2 billion dollars settlement of the CTA lawsuit. At this time the language or a bill number is not available for analysis. However it is projected that CTA will introduce language sometime this week. Therefore stay tuned for further legislative reports.

CCTE Policy Framework

The California Council on Teacher Education (CCTE) supports and encourages approaches to the preparation and continuing development of teachers which:

• Work toward the integration of the professional preparation of educators into career-long professional development involving sound theory and effective practices at all stages.

• Establish and foster strong support programs for teachers at all stages of their careers, particularly at the beginning stage, to help attract and retain high-quality teachers; such programs should include a role for university-based personnel as well as practitioners from the schools.

• Recognize and support alliances that work to improve preservice preparation, induction, and professional development of educators.

• Assure that professional programs include both scholarly study and school-based practice involving collaborative exchanges and cooperation between university and school personnel.

• Recognize the critical importance of valuing and continuously affirming cultural, linguistic, and ethnic diversity throughout the teacher education and P-12 curriculum.

• Foster the strong and balanced preparation of teachers in subject matter content, foundational studies, multicultural and multilingual education, and sound pedagogical practice at all levels of the professional development continuum.

• Assure that the guidelines, regulations, and laws governing the preparation of teachers and other educational personnel in California are based on, and are continually informed by, research and best practice; and that these guidelines, regulations, and laws reflect the considered opinions and voices of experts in the field.

◆ Include multiple and alternative approaches to the admission, retention, and credential recommendations for prospective teachers and in evaluation of inservice teachers; and assure that all assessment measures used to evaluate teacher candidates and teachers at any point in their preservice preparation and inservice practice are valid, unbiased, and relevant to teaching and learning practice.

• Support accreditation and evaluation processes which improve professional practice and which are conducted in an unbiased, collegial atmosphere by university and school professionals.

• Seek and ensure the active participation of the teacher education community in policy discussions and decisions regarding preservice education and the professional development of educators.

• Foster public and political support for education at all levels, pre-K to university, with an equitable commitment of resources to maximize teaching and learning.

• Recognize that quality teacher education is an intensely interactive and highly individualized activity requiring stable and adequate financial and personnel resources for ongoing development of effective teacher preparation programs.

Message from CCTEVice President For ATE

The Association of Teacher Educators (ATE) Summer Conference was held from July 29 through August 2, 2006, at the Hyatt Regency Philadelphia at Penn's Landing. Preliminary figures indicate that it drew the third largest number of participants ever for an ATE summer conference. The theme of the Conference, "Reinventing the Educational Landscape: Renewing Hope, Heart, and Vision for Teachers, Learners, and Communities" was reflected in the three Plenary Sessions featuring keynote speakers, Dr. Lindamichellebaron, a poet, storyteller, and educator, Philadelphia Mayor John F. Street, and Mr. Paul G. Vallas, Superintendent of Philadelphia Schools. The theme was also reflected in a series of special presentations as well as in many of the individual sessions on research and best practices presented by ATE members.

As a newly elected ATE Board of Directors member, I traveled to the conference early to attend my first Board of Directors meeting, participate in the Leadership Academy activities, and set up the conference display advertising San Diego as the venue for the upcoming February 17-21, 2007, ATE Annual Meeting. The conference began with a Reception for Newcomers at which all the Board members greeted the new attendees. Then we were off to ATE President Jane McCarthy's Presidential Reception for all participants, at which there was a fabulous jazz ensemble and scrumptious food. It was a very busy week, with several Board meetings, two 2007 Conference planning meetings, several Leadership Academy activities, a Council of Unit Presidents (CUP) meeting at which I represented CCTE on behalf of our CCTE President, Reyes Quezada, and a Legislative Committee meeting.

Besides all the stimulating presentations and discussions at the conference, participants conveniently walked from our hotel to several historic places around Philadelphia. Despite a heat wave that hit the Northeast just as the conference started, we kept cool in the air conditioned hotel rooms and pool and on a relaxing evening riverboat cruise and dinner.

A highlight of the places we visited around Philadelphia was a bus trip to see Norris Square. It is a large area in the inner city in which one motivated local resident transformed abandoned tracts of land and vacant lots that were once owned and monopolized by drug dealers. With the help of other largely Latino residents in the neighborhood, the Preservation Society, and now some grants, the area has been changed into lush flower gardens, vibrant murals, and simulated African and Puerto Rican villages. We were served large platters of homemade Puerto Rican delicacies, and we all left feeling the power of what one person can do to solve community problems.

ATE is sponsoring the Second National Congress on

Teacher Education on October 13, 14, and 15, 2006, at the Hyatt Regency Washington on Capitol Hill. The purpose of this meeting is to examine and write about what we know and need to know to ensure high quality teaching and teacher education in the United States, and to develop an action plan to get where we need to go. With the reauthorization of No Child Left Behind (NCLB) likely to occur in December 2006 or January 2007, the group will reflect on this legislation and what may or may not need changing in it to achieve quality teaching. This is a working session with group facilitators led by Marilyn Cochran-Smith, Robert Houston, and other ATE members including myself. I hope that many CCTE members will participate in this Congress. If you can not attend, please email me your thought and comments on NCLB and quality teaching. The work of the Congress will be compiled into a 2007 publication. Early bird registration is \$300 by September 15, 2006. The 2007 ATE Annual Meeting will take place on February 17-21 in San Diego at the Manchester Grand Hyatt Hotel on the harbor waterfront next to Seaport Village. The ATE Annual Meeting theme is the same as the summer conference, "Reinventing the Educational Landscape: Renewing Hope, Heart, and Vision for Teachers, Learners, and Communities." Sally Botzler and I are Co-Chairs of the Local Arrangements Committee and are busy arranging the attendance of student teachers from local universities, securing student entertainment, finding volunteers to staff the welcome tables and stuff folders, soliciting corporate sponsorships, arranging local media, securing local educators to greet participants, and arranging an ATE Leadership Academy site visit to two local schools in San Diego. The conference promises to be a lively one with many inspiring speakers and sessions. I hope that California will demonstrate a strong presence at this meeting and I urge all of you to attend this conference and to encourage your colleagues to do so as well. Call for Proposals for Research and Practice Sessions at the Spring 2007 CCTE Conference

The California Council on Teacher Education (CCTE) invites submission of research and practice proposals for the Spring 2007 Conference to be held March 29-31 at the Sainte Claire Hotel in San Jose. The theme of the Spring 2007 Conference is "The Growing Nexus—Education and the Private Sector." Proposals are encouraged on that theme, but not limited to it. Proposals are sought for several types of sessions: poster sessions, interactive sessions, demonstrations, workshops, and formal presentations, both individual and groups.

General Procedures: CCTE is interested in receiving proposals from faculty directly involved in teacher education programs, county and school district personnel engaged in BTSA and other teacher induction and professional development efforts, and graduate students conducting research related to teacher education.

How To Submit Proposals: Proposals must be submitted electronically. Submit (a) an email file cover sheet listing the names, affiliations, addresses, work and home telephone numbers, and email addresses, along with requested audiovisual equipment; and (b) an email file attachment (preferably in Microsoft Word or Microsoft Office) of a maximum 3-page, single-spaced proposal without names of the presenters. Content of the Proposal: Include the following: A brief overview of the study/project/program session including purpose/objectives, theoretical framework, methods, data source, results/conclusions/points of view, significance to the field of teacher education, and proposed style of presentation.

Deadline: Proposals for the Spring 2007 Conference must be received by January 1, 2007.

Criteria for Selection: The selection criteria are: the proposal contributes to the knowledge base of preservice and inservice teacher education; the proposal is methodologically or theoretically sound; and the proposal clearly states its significance for teacher educators.

Scheduling: The concurrent research and practice sessions will be scheduled on Thursday and Friday of the Fall Conference at times to be determined. Persons submitting proposals must be planning to register for and attend the Conference in order to be available once proposals are accepted and sessions are scheduled.

Miscellaneous: All presentations at CCTE Conferences are eligible for inclusion on the CCTE website following the Conference, and for submission to the ERIC Clearinghouse on Teacher Education. Papers resulting from accepted proposals will also be considered for publication in *Teacher Education Quarterly* or *Issues in Teacher Education*, the two CCTE journals.

CCTE Calls for Nominations for

"Quality Education Partnership Award for Distinguished Service to Children and the Preparation of Teachers"

At each Spring and Fall Semi-Annual Conference, CCTE honors a teacher education program which exemplifies collaborative efforts between a college/university and a K-12 school/district. The CCTE Awards Committee now invites nominations (and self-nominations) from programs in Northern California for the "Quality Education Partnership Award for Distinguished Service to Children and the Preparation of Teachers" that will be presented at the Spring 2007 Conference in San Jose. Next summer the Awards Committee will seek nominations of programs in Southern California for the award to be presented at the Fall 2007 Conference in San Diego.

Nominations must be submitted via e-mail.

Nominees for this semi-annual CCTE award must reflect collaboration between college/university administration and faculty and K-12 school administration and faculty (individual schools, school districts, or county offices of education) in the planning as well as the implementation of the program to be honored. Eligible programs must have been in place for a minimum of three academic years. Such programs may involve public or private/independent colleges/universities and public or private K-12 schools. Nominations must show clear evidence that as a result of the program, all partners have benefit-ted — e.g., children, student teachers, beginning teachers, cooperating teachers, other teachers and/or administrators in the school or district, and college/university faculty.

Nominations must include the following information: The names of the leading participants in the collaborative effort; a description of the school/district/county office and its population; a history of the program, including original goals and/or research questions being addressed; a description of the perceived successes of the effort, including any synopses of evaluative data collected; and future plans for the project.

Nominations must be submitted jointly by the K-12 school/district/county office and the institution of higher education with a statement of verification by the appropriate college/university and school/district officials. Each official named in the document should send a separate e-mail verification statement.

The total nomination document should not exceed five pages.

Toward this end CCTE will, depending upon nominations received and the subsequent deliberations of the Awards Committee, continue the tradition begun by SCATE of honoring educators in the following categories at the Spring 2007 Conference:

Robert R. Roth Distinguished Teacher/Administrator New to the Profession: This award is intended for a teacher or administrator who has worked six years or less at a K-Adult school site, district office, or county office of education. The awardee must exemplify excellence in their primary assignment and in their work to improve the preparation, induction, and professional development of educators.

Distinguished Teacher/Administrator: This award recognizes and honors an outstanding teacher and/or outstanding administrator who has worked more than six years at a K-Adult school site, district office, or county office of education. The awardees must exemplify excellence in primary assignment and in work to improve the preparation, induction, and professional development of educators.

Distinguished Teacher Educator: This award recognizes and honors an outstanding teacher educator who is located at a university/college, community college, or educational agency other than K-12 districts or county offices. The awardee must exemplify excellence in work to improve the preparation, induction, and professional development of educators.
