### **About the University:**

The newest addition to the California State University system, California State University Channel Islands (CSUCI) opened in 2002 with 629 transfer students and welcomed its first freshman class in fall 2003. Since that time, the University has grown and developed into one of the premier public universities not only in the Cal State system but also in the nation. Indeed, in its 2018 ranking, U.S. News & World Report listed CSUCI as the 18<sup>th</sup> highest-ranked regional public university in the western United States. Moreover, CSUCI was ranked 18<sup>th</sup> of over 1,300 schools in CollegeNET's Social Mobility Index in 2017. In a commitment to inclusive excellence of opportunity for its students, the University offers an array of degrees and community and social activities.

CSUCI is a public comprehensive university that engages students in critical inquiry and is dedicated to educating leaders for a global society. ## **Qualifications:**

<u>Minimal Qualifications</u> – Applicants must have Doctoral degree in Education or a closely related field. ABD candidates will be considered but must have completed the Doctoral degree by **August 18, 2020**.

- Experience teaching in a Spanish Dual Language Instruction (bilingual) K-12 setting.
- Record of successful credentialed K-12 school teaching for a minimum of three years, with demonstrated effectiveness in teaching multi-ethnic, multicultural and/or multi-lingual students using a variety of methods and technologies.
- Commitment to student success and diversity in K-12 settings.
- Evidence of commitment and ability to work in teams.
- An emerging record of scholarship in one or more areas of emphasis in education.
- Evidence of commitment to one's own discipline and to the broader institution.
- Applicants should demonstrate the commitment to effectively work with and engage a diverse student population and evidence of how they would successfully mentor minoritized students with special focus on Latinx, African-American, and Native American students.

## **Preferred Qualifications**

- Doctoral specialization in Dual Language Instruction or Bilingual Education.
- Professional expertise and demonstrated excellence in teaching methods courses and clinical practice supervision at the university level.
- Record of positive relationships with school district personnel, students, and families.
- Credential emphasis in bilingual education or equivalent.
- Experience working in Teacher Residency Programs.
- Experience working with students with special learning needs.
- Experience collaborating or co-teaching with related service providers.
- Experience in and commitment to ongoing, outcomes-based, program assessment of teaching and learning.
- Knowledge of regional or national accreditation processes and preparation of required documentation.
- Experience in on-line or blended teaching and course development.
- Record of grant and contract acquisition.

## **Responsibilities**

- Teach methods courses in Dual Language Instruction and related content areas.
- Coordinate Bilingual Authorization Program.
- Scholarly work or emerging research agenda that leads to peer reviewed publications.
- Supervise teacher candidates in public schools.
- Service activities in the School of Education, University and Community.
- Advise students.

Screening of applications will begin **December 2, 2019**. Priority will be given to applicants who meet the screening deadline; however, the position will remain open until filled.

- 5. a statement describing your experience mentoring and/or working with minoritized students with a special focus on Latinx, African-American, and Native American students, and
- 6. a teaching philosophy describing how you plan to engage and interact with students, with a special focus on Latinx, African-American, and Native American students.

In later phases of the search process, applicants may be requested to provide verification of terminal degrees, licenses and certificates.
